ELECTRONIC DISCHARGE SUMMARY

To improve communication and the continuity of your care, Wolper has implemented a new integrated electronic discharge summary. Clear and comprehensive clinical information from your Wolper multi-disciplinary team is prepared on discharge and sent electronically to your GP and other care providers as required. The new format will support you for your ongoing care needs. Every department contributes to your discharge summary including Medical. Nursing, Allied Health, Discharge Planning and Pharmacy. The Summary is a detailed and concise record of your stay with us at Wolper and will be loaded onto your "My Health Record" from early 2023 as per your instructions.

PATIENT & CARER SATISFACTION SURVEY

SUSTAINABLE HEALTHCARE COMMITMENT

An Environment & Sustainability Committee has been established to assist in managing environmental impacts, reduce Wolper's carbon footprint and improve sustainability to benefit the organisation and the community. The committee comprises of representatives from all departments and priority projects are being identified and implemented including recycling batteries, reducing single use products and installing solar panels on the hospital roof.

ANTIMICROBIAL STEWARDSHIP

To demonstrate compliance with the Antimicrobial Stewardship Clinical Care Standard. Wolper monitors antimicrobial usage and appropriateness of prescribing and reports the results to the Wolper Medical Advisory Committee and the Wolper Board of Directors. In August this year 15 patients who received antibiotics were reviewed by the Clinical Pharmacist. Here are the results:
